

General Guidelines for Synopsis

- Participating organizations to send a synopsis containing 1,500-2,000 words (including appendices and references) electronically (email attachment or CD) in MS Word 2,000 or higher version.
- Font used for all texts should be in Arial/Calibri /Times New Roman 12 point font. The main headings and the sub-headings should be bold.
- The page margins must be of 01 inch from the top edge and a 01 inch margin on both sides and bottom of the page. All texts should be justified.
- The synopsis should be handed over with the registration payment on or before 31st January 2023.
- Evaluators are not expected to visit companies.
 Therefore, the company synopsis should be endorsed by the organization's Chairman/CEO/MD/Director as true and correct (company rubber stamp/seal and signature).
- The synopsis which does not adhere to the above format will be rejected at the application level.

Template of the Synopsis

- This should be in very brief and if required some annexures.

Companies need to follow the template below. All companies registered for the competition will receive this template separately.

01. The situation in the organization before implementing the best management practice (a brief comparison with the previous year's situation should be indicated)
- 10 marks
– make it very brief
02. A brief description of the "best management practice" your company practices highlight novelty and innovation (Eg Human resource management practice/marketing practice/operational practice, Environmental-friendly practices etc.)
- 15 marks
 select one critical best management practice and explain it. Pls, do not write many practices here. Select the topmost important one to be showcased
03. How has the said best management practice contributed to bringing back to the business/opportunities for sustaining and growing the business (Provide a minimum of three pieces of evidence)
- 30 marks
 clearly present three pieces of evidence that indicate how the above chosen best practice has contributed get the business sustaining and growing
04. How could the output and outcome of the said best management practice be measured or described? (Focus on industry impact, societal impact, contribution to the economy, profit and popularity of product/services)
- 25 marks
– Bring your number-based evidence/results/indicators to showcase output and outcome
05. Measures that are taken to sustain and consolidate the process
- 15 marks
– show in brief specific actions taken to sustain and consolidate it.
06. A brief description of any other supporting aspects
- 5 marks

What is the evaluation process?

Evaluation Criteria

First Round Evaluation - Desk review of the synopsis - 50% Second Round Evaluation - Oral Presentation (virtual) - 50%

First Round Evaluation - Desk review of the synopsis

The synopsis is scrutinized by a panel of evaluators appointed by CPM Sri Lanka based on the criteria enumerated for the synopsis.

How has the said best management practice contributed to bringing back to the business/opportunities for sustaining and growing the business (Provide a minimum of three pieces of evidence)	30 marks
How could the output and outcome of the said best management practice be measured or described? (Focus on industry impact, societal impact, contribution to the economy, profit and popularity of product/services)	25 marks
Measures that are taken to sustain and consolidate the process	15 marks
A brief description of any other supporting aspects	5 marks

Second Round Evaluation – Oral Presentation (Virtual)

Organizations are expected to make a 10 minutes' multi-media presentation based on the factors structured and articulated in the synopsis (20th February to 26th February 2023). The presentation party should not exceed 03 speakers.

Oral Presentations criteria;

Presentations will be evaluated as per the following criteria.

Assessment Criteria	Marks Allocated
Background of the company and the Justification of the best management practice	10 marks
Justification with evidence of bringing that to business efforts/ sustaining and growing the business	50 marks
Impact, Key Findings, and sustainability	20 marks
Overall Effectiveness of the presentation	20 marks

Other Guidelines for Oral Presentations

- Organizations that have applied for awards must make a PowerPoint presentation clearly explaining their best management practices.
- Time allocation 20 Minutes per Group (10 minutes presentation time + 10 minutes Q & A Time)
- Maximum of three (03) presenters should be allocated for a presentation
- Dress Code Office Attire
- All presenters (maximum of 03) must be present at the given time slot

Information Security

The Institute assures the security of information provided by companies. It will not be divulged to a third party unless for technical evaluation to a panel of judges. The evaluators will adhere to the confidentiality of information ensured by CPM Sri Lanka.

Authority

The Panel of Judges will be the sole and final deciding authority regarding the evaluation procedures and the recipients of the awards.
